Settlement Agreement

The parties' counsels hereby advise the honorable court that they have reached a settlement as follows:

1. The defendants, by the State of Israel, will pay the plaintiffs a total amount of 40,000 ILS (forty thousand ILS), including attorney's fees according to the law and VAT for the full and final settlement of their entire claims in the action filed in C.A. 3906/96 – in connection with the accident being the subject matter of the action, whether now existing or which may exist in the

future of any kind and nature whatsoever including claims of various benefactors, whether now existing or which may exist in the future of any kind and nature whatsoever, and all this without assuming liability or acknowledging the amount of the damage.

2. From the date of the above payment, no person and/or body will have any claim and/or demand in connection with and/or concerning the accident being the subject matter of the statement of claim and/or the action in C.A. 3906/96 – its causes and/or anything related thereto and/or arising there-from.

The plaintiffs will compensate the State of Israel and/or defendant No. 1 and/or defendant No. 3 immediately upon their first demand if any claim and/or demand is filed against it by any person or body as aforesaid, for any payment paid by them for the accident including any damage which may be suffered by them as a result of the filing of any such claim and/or demand.

- 3. The amount specified in section 1 above will be paid to plaintiffs' counsel within 45 days from the date plaintiffs' counsels deliver to defendants' counsels a certified copy of a judgment giving the above settlement an effect, otherwise said amount will bear linkage differentials and interest from the date of delivery of the judgment to defendants' counsel.
- 4. Each party will bear its own expenses.
- 5. The honorable court is hereby requested to give the above settlement an effect of a judgment.
