## **Petition for Writ of Habeas Corpus**

The Honorable Court is hereby requested to order the Respondent to show cause to this Honorable Court at a time set therefore, why he does not provide relatives of the detainees described below, and to order him to release them from detention.

In the alternative, the Honorable Court is requested to order that counsel for the detainees be allowed to meet with them and with their relatives.

As interim relief, the Honorable Court is requested to require the Respondent to provide precise details on what befell the detainees and enable their attorney to meet with them.

Because of the nature of the petition, the Honorable Court is requested to set a hearing date as early as possible.

The grounds for the petition are as follows:

## HCJ 5797/90

- Petitioner 1 is the sister of Y. A., from Azariya, who was detained on 8 December 1990, and the sister of M. A., from Azariya, who was detained on 8 December 1990.
- Petitioner 2 is the brother of R. R., from Azariya, who was detained on 17 December 1990. Petitioner 2 received a postcard on 20 December 1990 telling him that his brother was being detained at the military administration in Bethlehem.
- 3. Petitioner 3 is the sister of M. K., from Salfit, who was detained on 18 December 1990.
- 4. Petitioner 4 is the mother of A. I., from D'hiat al Barid, who was detained on 19 December 1990.
- 5. Several times, the Petitioners requested HaMoked: Center for the Defence of the Individual to locate their relatives. In accordance with the judgment given in HCJ 670/89, Odeh et al. v. Commander of IDF Forces in Judea and Samaria (not yet published), the place at which detainees are being held can be located by means of the "Control Center," which is administered by the Respondent.
- 6. The Petitioners' attorneys telephoned the Control Center and requested that it locate the detainees. However, as of the time of the filing of this petition, the detainees have not been located, including the brother of Petitioner 2. It was stated during the telephone conversation that it is possible to locate detainees only ten days after they are detained.
- 7. On 21 December 1990, the Petitioners' attorneys requested, in writing, the State Attorney's Office, through its head of the HCJ Division, Nili Arad, to provide the name of the place in which the relatives of the Petitioners are being held. A copy of this letter is attached hereto and marked P/1.
- 8. The Petitioners attorneys spoke by telephone with Ms. Arad on 23 December 1990 and with her clerk on 28 December 1990 in the matter of locating the detainees, but the conversations were unproductive. Another letter was sent to Ms. Arad on 28 December 1990, a copy of which is attached hereto and marked P/2.
- 9. The affidavits of Petitioners 2, 3, and 4 are attached hereto and marked P/3, P/4, and P/5, respectively.
- 10. In light of the above, the Honorable Court is requested to issue the orders requested hereinabove.

Re: Failure to locate detainees

- 1. I am writing to you following the breakdown that recently occurred in implementing the procedures of "Notification of Detention to Families of the Detainees and to the Red Cross." I am referring in general to HCJ 670/89, *Odeh et al. v. Commander of IDF Forces et al.* (not yet published), and request that you immediately intervene in the matter.
- 2. These are the details on the detainees that HaMoked: Center for the Defence of the Individual has collected over the past two weeks:
  - A. Y. A., born in1968, from Azariya, who has been detained since 8 December 1990.
  - B. M. S., born in 1970, from Azariya, who has been detained since 8 December 1990.
  - C. M. F., born in 1962, from Azariya, who has been detained since 14 December 1990.
  - D. U. G., from Azariya, who has been detained since 14 December 1990.
  - E. R. R., born in 1956, from Azariya, who has been detained since 17 December 1990.
- 3. In a telephone inquiry with the Control Center on 20 December, these detainees were not located.
