1. Following our letter dated December 14, 2014 and following our telephone conversations, please be advised that the appeals of your clients against the restraining orders issued against them, prohibiting them from staying in Jerusalem, will be heard by a representative of the Home Front Command, on Monday, December 22, 2014.
2. In order to enable your clients to attend the hearing in their appeal, the hearings will be held in the **Ofer Camp**, according to the following order:
  - a. 10:00-10:30 - hearing in the matter of \_\_\_\_\_ Darabas, ID No. \_\_\_\_\_
  - b. 10:30-11:00 - hearing in the matter of \_\_\_\_\_ Darawish, ID No. \_\_\_\_\_
  - c. 11:00-11:30 - hearing in the matter of \_\_\_\_\_ Gul, ID No. \_\_\_\_\_
3. Furthermore, and as I informed you in our telephone conversation, **no interpretation services will be rendered during the hearing.**
4. With respect to \_\_\_\_\_ Gul, ID No. \_\_\_\_\_, who, as you informed, was prohibited from staying in the Judea and Samaria Area by the GOC Central Command, it should be clarified, that to the extent he wishes to attend the hearing, he should submit an application to the GOC Central Command and request a relaxation in the conditions of the order on that date. We shall assist in this matter to the extent possible. Alternatively, he can present his arguments through you, or in writing.
