Your query dated December 28, 2015 was received by our department and transferred to the competent officials for a response.

Below please find the response of the IDF Spokesperson's Public Communication Department:

- 1. The orders you request are not located in a single IDF unit. In order to respond to your query, inquiries have been made with several relevant officials in an attempt to locate all requested orders. As a result of this inquiry, the orders detailed below have been located.
- 2. Below please find a detailed list of demolition orders issued pursuant to Regulation 119 of the Defense Regulations, signed by the GOC Home Front Command and the GOC Central Command between 2008 and 2015. The list contains information as to the type of order and the date of its execution, inasmuch as we were able to obtain this information. The list also specifies which orders were issued following a judicial decision pertaining thereto, as requested in the query.
 - a. Sealing order issued on August 25, 2008 in Jabal al-Mukabber in East Jerusalem order executed on January 19, 2009.
